WILLATOOK WIND FARM SPONSORSHIP FUNDING

Thank you for your interest in the Willatook Wind Farm Sponsorship Fund.

The Willatook Wind Farm Sponsorship Fund has been established to support local community groups during the project development phase, with up to \$20,000 available per year to eligible organisations and community groups. The fund is designed to help local community groups to deliver and enhance their services, programs, initiatives and facilities.

Once the wind farm is commissioned, the sponsorship fund will be replaced by the Willatook Wind Farm Community Benefit Fund, which will continue annually for as long as the wind farm is operational. Guidance and feedback will be sought from Moyne Shire Council and the local community to help shape the design and eligibility criteria of this fund.

Applications are administered by Wind Prospect.

GUIDELINES

- Fund of \$20,000 per calendar year
- Fund finishes when Community Benefit Fund begins OR work on developing the project ceases
- Any unused funds will be rolled over to the following year, or into the Community Benefit Fund
- Successful applicants will be decided by Wind Prospect
- Preference will usually be given to applications within geographic proximity to the project
- Applications can be received at any time
- Initially, funding totaling \$5000 will be granted each quarter (to a total of \$20,000 per calendar year)
- Grants greater than \$5000 may be awarded, at the discretion of Wind Prospect.
